**4.1 Description of first aid measures**

<b>Eye</b>	If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.

**11.1 Information on toxicological effects**

**Acute toxicity** Acute ingestion of borates can cause gastrointestinal distress, including nausea and vomiting, along with potential neurological symptoms such as dizziness and confusion.

**12.1 Toxicity**

Borates may be harmful to aquatic organisms, particularly at high concentrations. They can affect fish and invertebrates by disrupting osmoregulation and causing developmental and reproductive issues.

**12.2 Persistence and degradability**

The mobility and relative biodegradability of borates typically reduce long-term environmental persistence.

**12.3 Bioaccumulative potential**

Borates do not typically bioaccumulate in organisms.

**12.4 Mobility in soil**

Borates are relatively mobile in soil due to their solubility in water.

Avoid contamination of drains and waterways.
