5. FIRE FIGHTING MEASURES

Combustible. May evolve toxic gases (carbon oxides, hydrocarbons) when heated to decomposition. Finely divided dust may form explosive mixtures with air.

Due to the physicochemical properties of maleic acid it is assumed to be mainly distributed into water (Trent University, 1999 & 2004, cited in OECD SIDS 2004). From the water surface, maleic anhydride, as well as the product of hydrolysis maleic acid will not evaporate into the atmosphere.

13.1 Waste treatment methods

Waste disposal Dilute with water and neutralise with soda ash or sodium bicarbonate. Ensure solution is neutral to litmus and flush to sewer with excess water. Alternatively, mix with flammable solvent burn in an incinerator fitted with afterburner and scrubber. Prevent environmental contamination as aquatic life may be threatened.
