4.1 Description of first aid measures

Eye	If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.
Inhalation	If inhaled, remove from contaminated area. To protect rescuer, use a Type A-Class P3 (Organic vapour, Particulate) respirator or an Air-line respirator where an inhalation risk exists. Apply artificial respiration if not breathing.

Aqueous solutions of chloral hydrate decompose rapidly when exposed to ultraviolet light, with the formation of hydrochloric acid, trichloroacetic acid and formic acid. Chloral hydrate slowly volatilises on exposure to air.

May evolve toxic gases (carbon oxides, hydrogen chloride, chlorides, phosgene, hydrocarbons) when heated to decomposition.

11. TOXICOLOGICAL INFORMATION

11.1 Information on toxicological effects

12. ECOLOGICAL INFORMATION

12.1 Toxicity

Chloral hydrate: The toxicity values (most conservative value) of fish, invertebrates and algae are LC50 = 97 mg/L, EC50 = 99 mg/L and ErC50 = 96 mg/L, respectively. These values suggest that the chemical is not expected to exhibit Aquatic toxicity (REACH).

12.2 Persistence and degradability

Not expected to be persistent in the aquatic environment.

12.3 Bioaccumulative potential

The estimated log Kow values for 2,2,2-trichloroethane-1,1-diol (Chloral hydrate) is less than 4 (Log Kow = 0.99). The potential for Chloral hydrate to bioaccumulate in the tissues of organisms that inhabit aquatic or terrestrial matrices is negligible as the BCF factor for the substance is less than 2000 (REACH).

12.4 Mobility in soil

Chloral hydrate is not expected to adsorb to suspended solids and sediment.

12.5 Other adverse effects

Avoid contamination of drains and waterways.
