4.1 Description of first aid measures

Eye If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.

If silver nitrate is released to water, the silver will precipitate out with natural chlorides. The nitrate can persist indefinitely, and is a nutrient with potential to disturb ecological balance (algal blooms etc). Toxic to sewage organisms at 0.3ppm. Silver may bioaccumulate in aquatic plants and animals and is toxic to fish above 0.01 ppm.
