Additional information BUFFER SOLUTIONS: Mixtures of weak acids/weak bases and their salts are called buffer solutions as they resist changes in their hydrogen ion concentration upon addition of small amounts of acid or base, with their pH tending to remain unchanged. They are used to standardize pH meters.
