12.2 Persistence and degradability

Magnesium sulphate heptahydrate is not considered persistent in the environment. It readily dissolves in water and dissociates into magnesium and sulfate ions, which are typically available for uptake by plants or microbial degradation.

12.3 Bioaccumulative potential

Magnesium sulphate heptahydrate does not bioaccumulate in organisms. The magnesium and sulfate ions are essential nutrients for many biological processes and are efficiently regulated and excreted by living organisms.

12.4 Mobility in soil

Magnesium sulphate heptahydrate is highly mobile in soil due to its solubility in water. The magnesium and sulfate ions can leach through the soil profile, especially in well-drained soils, and can be readily taken up by plants. Soil pH and organic matter content can influence its mobility.
